AIRSIDE ACCESS WITH MOTOR VEHICLES The INSURANCE PROGRAM and the AIRPORT MANAGING BODY'S POLICY GE.S.A.C. SpA

The INSURANCE PROGRAM of the AIRPORT MANAGING BODY GE.S.A.C. SpA, available in full at the following link: <u>http://www.aeroportodinapoli.it/gesac/programma-assicurativo</u>, is the official document containing the insurance rules in force at the airports of Naples Capodichino and Salerno Pontecagnano. It sets the mandatory requirements to which all Persons operating in the airports must comply in order to enter the airside with vehicles owned or in use.

MANDATORY REQUIREMENTS FOR ACCESSING TO AIRSIDE

- Third party liability insurance policy (RCT) (for specific activities and/or contracts carried out on the airside) with maximum ceiling varying according to the type of activity performed on the airside and including the specific conditions set out in the current insurance program.
- Motor Third Party Liability motor insurance policy (the "RC Auto") with a ceiling of not less than € EUR 30,000,000.00_and including the following additional warranties:
 - extension of coverage for movement and parking throughout the airside, mentioning by way of example but not limited to the following areas: Runway, Junctions, Taxiways, Aircraft parking areas;
 - Inclusion of "third-party fire claim" warranty for movement and parking with a ceiling of not less than EUR 30,000,000.00.

THE AIRSIDE CAN BE ENTERED WITH VEHICLES ADHERING TO THE AIRPORT MANAGING BODY'S POLICY

GE.S.A.C.'s policy applies to all Persons operating at the airports of Naples Capodichino and Salerno Pontecagnano. It fulfils both requirements for operating in the airside:

- RCT Section If you do not have an adequate Third party liability insurance policy (RCT) for the activity to be performed in airside you can join the GE.S.AC.'s Third party liability insurance policy (RCT). The latter ensures at a very reasonable cost the activity towards third parties in compliance with the requirements of the GE.S.A.C. insurance program.
